A	Ensure parity across MassHealth ACOs and MCOs regarding HCV prior authorization requirements.		

State Overview

As of September 2022, 1,934,907 individuals were enrolled in Medicaid (MassHealth) and CHIP.¹ It is estimated that as of 2016, 38,100 people were living with HCV in Massachusetts.² 56 percent of MassHealth beneficiaries are enrolled in a Managed Care Organization (MCO),³ Accountable Care Organization (ACO)⁴ or Accountable Care Partnership Plan (ACCP).⁵ The remaining beneficiaries participate in Primary Care Case Management (PCCM) programs (33 percent) operated by the state or Fee-For-Service (FFS) programs (11 percent).⁶

MassHealth contracts with 2 MCOs: BMC HealthNet Plan and Tufts Health Together; 3 primary care ACOS: Community Care Cooperative (C3), Mass General Brigham (formerly AllWays Health Partners), and Steward Health Choice; and 13 ACCPs: Be Healthy Partnership, Berkshire Fallon Health Collaborative, BMC HealthNet Plan Community Alliance, BMC HealthNet Plan Mercy Alliance, BMC HealthNet Plan Signature Alliance, BMC HealthNet Plan Southcoast Alliance, Fallon 365 Care, My Care Family, Tufts Health Together with Atrius Health, Tufts Health Together with BIDCO, Tufts Health Together with Boston Children's ACO, Tufts Health Together with CHA, and Wellforce Care Plan.⁷

The Massachusetts Medicaid Preferred Drug List lists ledipasvir/sofosbuvir, Mavyret, and sofosbuvir/velpatasvir (generic Epclusa) as preferred regimens.8

Deductions		Policy	
Prior Authorization		MassHealth's preferred drug list designates all DAA regimens as requiring prior authorization. However, for many patients, the prior authorization requirement has been effectively removed due to MassHealth's use of pharmacy claims technical software, called SmartPA. MassHealth's SmartPA software links diagnosis codes from medical claims during pharmacy claims adjudication, allowing some claims to process at the pharmacy without a separate prior authorization form needing to be submitted. Patients can thus bypass the prior authorization process if they are prescribed a preferred HCV treatment regimen and meet the following additional requirements: the patient must be at least 3 years old, was never covered for hepatitis C treatment via MassHealth in the past, has no paid MassHealth pharmacy claims suggestive of decompensated cirrhosis in all claims history, and has no history of paid MassHealth claims in the past 90 days for a drug that may lower DAA efficacy.

Access in Managed Care	-8	Some managed care plans that contract with Massachusetts impose greater restrictions than FFS and have not yet removed prior authorization for patients who meet SmartPA criteria. Berkshire Fallon Health Collaborative, Fallon 365 Care, and Wellforce Care Plan share the same formulary documents and still appear to require prior authorization for all patients. My Care Family and Mass General Brigham/AllWays Health Partners formularies do not appear to require prior authorization for Epclusa, but the clinical criteria do not mention the SmartPA process. Be Healthy Partnership does not appear to require prior authorization for Epclusa or Mavyret. Steward Health Choice, Community Care Cooperative (C3), the BMC Health Net plans, and the Tufts Health Together plans and the pharmacy without prior authorization.
