State Overview

As of February 2022, 847,424 individuals were enrolled in Medicaid and CHIP.¹ It is estimated that as of 2016, 21,900 people were living with HCV in Nevada.² Nevada Medicaid operates a fee-for-service (FFS) and managed care program. Most beneficiaries, 83 percent, are enrolled in an managed care organization (MCO). The remaining 17 percent participate in FFS.³ Nevada Medicaid contracts with four managed care organizations (MCOs): Anthem Blue Cross and Blue Shield Healthcare Solutions (Anthem)⁴, Health Plan of Nevada, Molina Healthcare of Nevada⁵ and SilverSummit Healthplan (SilverSummit).⁶

The Nevada Medicaid Preferred Drug List includes Epclusa, Harvoni, ledipasvir/sofosbuvir, and sofosbuvir/velpatasvir.⁷

Access in Managed Care	-8	Two MCOs, Health Plan of Nevada ¹³ and SilverSummit, ¹⁴ do not publish their criteria. Molina ¹⁵ and Anthem ¹⁶ both appear to impose the same requirements as FFS.		
Additional Restrictions	-4	Nevada Medicaid imposes additional restrictions as follows: 17 • Documentation of Genotype. • Documentation of chronic infection.
