State Overview

As of October 2023, 2,233,489 individuals were enrolled in Medicaid and CHIP in North Carolina.¹ It is estimated that as of 2016, 66,400 people were living with HCV in North Carolina.² North Carolina operates three different Medicaid programs. 69 percent of beneficiaries receive care from a managed care organization (MCO), 28 percent of beneficiaries receive care from physicians who contract directly with the state through a Primary Care Case Management (PCCM) system, and just 3 percent participate in the state's Fee-For-Service (FFS) program.³ North Carolina Medicaid contracts with 5 MCOs: AmeriHealth Caritas North Carolina, Inc. (AmeriHealth), Carolina Complete Health (Carolina Complete Health), Healthy Blue of North Carolina (Blue Cross Blue Shield), UnitedHealthcare Community Plan of North Carolina (UnitedHealthcare), and WellCare of North Carolina (WellCare).⁴

The North Carolina Medicaid Preferred Drug List includes Mavyret, sofosbuvir/velpatasvir, and Vosevi.5

Access in Managed Care		All MCOs, AmeriHealth, ¹¹ Carolina Complete Health, ¹² Healthy Blue of North Carolina, ¹³ UnitedHealthcare of North Carolina, ¹⁴ and WellCare of North Carolina ¹⁵ appear to impose the same requirements as FFS by linking to the NC DHHS Preferred Drug List and Clinical Coverage Policies. While they do link to the current PDL and appear to impose no greater requirements than FFS, Carolina Complete Health ¹⁶ and United Healthcare ¹⁷ continue to publish outdated prior authorization forms for Mavyret and sofosbuvir/velpatasvir on their websites.
