

State Overview

As of October 2022, 2,298,651 individuals were enrolled in Medicaid and CHIP. North Carolina has not expanded coverage to low-income adults. It is estimated that as of 2016, 66,400 people were living with HCV in North Carolina. North Carolina operates three different Medicaid programs. 69 percent of beneficiaries receive care from a managed care organization (MCO), 28 percent of beneficiaries receive care from physicians who contract directly with the state through a Primary Care Case Management (PCCM) system, and just 3 percent participate in the state's Fee-For-Service (FFS) program. North Carolina Medicaid contracts with 5 MCOs: AmeriHealth Caritas North Carolina, Inc. (AmeriHealth), Healthy Blue of North Carolina (Blue Cross Blue Shield), UnitedHealthcare of North Carolina, Inc. (UnitedHealthcare), WellCare of North Carolina, Inc. (WellCare), and Carolina Complete Health, Inc. (Carolina Complete Health).

The North Carolina Medicaid Preferred Drug List includes Mavyret, sofosbuvir/velpatasvir, and Vosevi.5

Access in Managed Care		AmeriHealth ¹¹ , Healthy Blue of North Carolina ¹² , UnitedHealthcare of North Carolina, ¹³ WellCare of North Carolina ¹⁴ and Carolina Complete Health impose the same requirements as FFS. ¹⁵		
Additional Restrictions	-6	North Carolina Medicaid imposes additional restrictions as follows: 16 • HCV RNA collected within 6 months of request. • Documentation of chronic HCV infection. • Patient must be evaluated for "readiness for treatment."
