
Hepatitis C: State of Medicaid Access Report Card

State Overview

As of October 2023, 118,356 individuals were enrolled in Medicaid and CHIP.¹ It is estimated that as of 2016, 2,600 people were living with HCV in North Dakota.² North Dakota operates a fee-for-service (FFS) program and contracts with one managed care organization (MCO): BlueCross and BlueShield of North Dakota (BCBSND).³ As of July 2022, 43.9 percent of beneficiaries were enrolled in a primary care case management program (PCCM), 29.3 percent were enrolled in FFS, and 26.8 percent were enrolled in an MCO.⁴ However, effective January 1, 2024, North Dakota's PCCM program ended and existing PCCM members were automatically moved to FFS.⁵ There are no current statistics on FFS and MCO enrollments. Pharmacy services are carved out of managed care contracts and administered by the FFS program.⁶

The North Dakota Medicaid Preferred Drug List lists Harvoni, sofosbuvir/velpatasvir, Sovaldi, and Vosevi as preferred regimens.

Prior Authorization	-8	Prior authorization is required for all HCV treatment regimens.8		
Fibrosis Restrictions		North Dakota Medicaid does not impose fibrosis restrictions. ⁹		
Substance Use Restrictions	-4	North Dakota Medicaid imposes a substance use counseling restriction. For patients with "history of alcohol use disorder or IV illicit substance use" who have used alcohol or IV illicit substances in the past year, and have not completed/are not currently enrolled in a treatment program within the last year, the provider must submit a Harm Reduction Program Participation Attestation before treatment is approved. The Harm Reduction Program Attestation may be completed by "any qualified healthcare provider." The form requires participation in a syringe service program or 2 Harm Reduction Pathway appointments. As of January 2024, toxicology labs are no longer required.		
Prescriber Restrictions		North Dakota Medicaid does not impose prescriber restrictions for initial treatment. ¹⁴		
Retreatment Restrictions	-8	For patients seeking retreatment, North Dakota Medicaid imposes additional restrictions due to "non-compliance," "defined as a medication possession ratio (MPR) of less than 80%." Patients seeking retreatment due to "non-compliance" must have participated in 1 visit focused on addressing adherence barriers within the past 180 days. "Adherence education may be provided by a pharmacist (may be billed through the MTM program) or clinic-based E&M billed service (provided by a nurse or independent practitioner)." It is also noted that North Dakota Medicaid requires specialists to be involved in therapy for retreatment. 15		
Access in Managed Care		Since January 1, 2020, pharmacy services are carved out of managed care contracts and administered by the FFS program. 16		



Additional Restrictions	-4	North Dakota Medicaid imposes additional restrictions as follows ¹⁷ :	
		All patients: Confirmation of chronic HCV infection.	
		 For patients with no or unknown liver fibrosis: Two positive HCV RNA levels must be collected at least 3 months apart or 1 positive HCV RNA with the last likely HCV exposure occurring at least 6 months before more recent positive test.
