State Overview

As of September 2023, 5,133,532 individuals were enrolled in Medicaid and CHIP. Texas has not expanded coverage to low-income adults.¹ It is estimated that as of 2016, 202,500 people were living with HCV in Texas.² As of July 1, 2022, most beneficiaries, 97 percent, are enrolled in an MCO; the remaining 3 percent participate in FFS.3 Texas Medicaid contracts with 16 managed care organizations (MCOs): Aetna Better Health, Wellpoint (formerly Amerigroup), BlueCross BlueShield of Texas (BCBS), Community Health First Plan (CHFP), Community Health Choice (CHC), Cook Children's Health Plan, Dell Children's Health Plan, Driscoll, El Paso Health (El Paso), FirstCare, Molina Healthcare of Texas (Molina), Parkland Community Health (Parkland), Scott & White RightCare, Superior HealthPlan (Superior), Texas Children's, and UnitedHealthcare (UHC)4. All MCOs apply FFS hepatitis C coverage requirements.5

Mavyret is the only preferred regimen on the Texas Medicaid Preferred Drug List.⁶

Access in Managed Care		Texas Medicaid's removal of prior authorization for Mavyret applies to "all Medicaid clients in managed care and fee-for-service." Additionally, all MCOs (Aetna Better Health, 13 Wellpoint, 14 BlueCross BlueShield of Texas, 15 Community Health First Plan, 16 Community Health Choice, 17 Cook Children's Health Plan, 18 Dell Children's Health Plan, 19 Driscoll, 20 El Paso Health, 21 FirstCare, 22 Molina Healthcare of Texas, 23 Parkland Community Health, 24 Scott & White RightCare, 25 Superior HealthPlan, 26 Texas Children's, and UnitedHealthcare 28) link to the Texas Medicaid Vendor Drug Program website and/or provider notices announcing the change.
