


# Hepatitis C: State of Medicaid Access Report Card

## Alabama



Grade	Recommendations to Improve Patient Access
B	<ul style="list-style-type: none"><li>• Remove prior authorization for HCV treatment.</li><li>• Remove retreatment restriction.</li><li>• Remove additional restrictions as described below.</li></ul>

### State Overview

As of August 2025, 938,822 individuals were enrolled in Medicaid and CHIP. Alabama has not expanded coverage to low-income adults.<sup>1</sup> It is estimated that as of 2016, 30,700 people were living with HCV in Alabama.<sup>2</sup> Alabama does not contract with any managed care organizations (MCOs).<sup>3</sup>

Alabama Medicaid imposes a general restriction on the total number of prescriptions it will cover per enrollee: "In most cases, adults are limited to five drugs per month, four of which may be brand name drugs. Three-month maintenance supply drugs do not count towards the prescription limit."<sup>4</sup>

The Alabama Medicaid Preferred Drug List includes Epclusa, Harvoni, Mavyret, Zepatier, and "all covered generics" (sofosbuvir/velpatasvir, glecaprevir/pibrentasvir, ledipasvir/sofosbuvir, elbasvir-grazoprevir).<sup>5</sup>

Deductions		Policy
Prior Authorization	-8	Prior authorization is required for all Direct-Acting Antiviral (DAA) HCV treatment regimens. <sup>6</sup> Although HCV treatments are included on the preferred drug list, they are only considered "preferred with clinical criteria in place," indicating that patients must meet certain clinical criteria for approval – equivalent to prior authorization.
Fibrosis Restrictions		Alabama Medicaid does not impose fibrosis restrictions. <sup>7</sup>
Substance Use Restrictions		Alabama Medicaid does not impose substance use restrictions. <sup>8</sup>
Prescriber Restrictions		Alabama Medicaid does not impose prescriber restrictions. <sup>9</sup>
Retreatment Restrictions	-8	Alabama Medicaid imposes retreatment restrictions. Alabama Medicaid only provides one course of treatment per lifetime. <sup>10</sup>
Access in Managed Care		Alabama Medicaid does not contract with MCOs. <sup>11</sup>
Additional Restrictions	-2	Alabama Medicaid imposes additional restrictions as follows: <ul style="list-style-type: none"><li>• Documentation of adherence counseling, and requirement to monitor adherence via RNA testing during treatment. Patients are required to sign a contract stating: "I understand that Medicaid will pay for only one course of medicine. If I do not take my medicine as prescribed, I will not be approved for another course of therapy."<sup>12</sup></li></ul>
