


# Hepatitis C: State of Medicaid Access Report Card

## Delaware



Grade	Recommendations to Improve Patient Access
A+	<ul style="list-style-type: none"><li>Continue to ensure broad access to HCV treatment.</li></ul>

### State Overview

As of June 2025, 244,962 individuals were enrolled in Medicaid and CHIP.<sup>1</sup> It is estimated that as of 2016, 6,300 people were living with HCV in Delaware.<sup>2</sup> 95% of Medicaid recipients are enrolled in a managed care organization (MCO) while 5% of beneficiaries are enrolled in fee-for-service (FFS).<sup>3</sup> Delaware Medicaid contracts with three MCOs: AmeriHealth Caritas Delaware, Delaware First Health, and Highmark Health Options (Blue Cross and Blue Shield of Delaware).<sup>4</sup>

The Delaware Medicaid Preferred Drug List includes Mavyret and sofosbuvir/velpatasvir.<sup>5</sup>

Deductions		Policy
Prior Authorization		Prior authorization is not required for preferred HCV treatment regimens. <sup>6</sup>
Fibrosis Restrictions		Delaware Medicaid does not impose fibrosis restrictions. <sup>7</sup>
Substance Use Restrictions		Delaware Medicaid does not impose substance use restrictions. <sup>8</sup>
Prescriber Restrictions		Delaware Medicaid does not impose prescriber restrictions. <sup>9</sup>
Retreatment Restrictions		Delaware Medicaid does not impose retreatment restrictions. Beneficiaries are “limited to one treatment cycle every 365 days.” <sup>10</sup>
Access in Managed Care		For initial treatment with preferred HCV treatment regimens, all MCOs (AmeriHealth Caritas Delaware, <sup>11</sup> Centene Delaware First Health, <sup>12</sup> and Highmark Health Options <sup>13</sup> ) impose the same requirements as FFS.  If the patient is treatment-experienced, AmeriHealth Caritas Delaware requires that the “Prescriber must be a specialist in hepatology, gastroenterology, infectious disease, HIV, or liver transplant.” <sup>14</sup>
Additional Restrictions		Delaware Medicaid does not impose additional restrictions. <sup>15</sup>
